
Operator Qualification

The Kentucky Gas Association has developed the Operator Qualification Covered Task Justification Guide. The Guide is designed to assist companies in identifying tasks relating to the job duties of their employees and those tasks performed by contractors and others that might be "identified covered tasks" as defined in Title 49 of the Code of Federal Regulations, Part 192, Subpart N.

The Guide was initiated as a project of the Kentucky Gas Association's **Education Committee** during the time that the pipeline operator qualification regulation was in the negotiated rulemaking process (neg-reg) after the U.S. Department of Transportation published its Notice of Proposed Rule and prior to the publication of the final rule on October 26, 1999. When the project was identified and initiated, an Operator Qualification Task Force was established to provide guidance for KGA member companies and others in the gas industry as they developed their company-specific pipeline operator qualification plans.

A consensus approach to analyzing covered tasks was utilized, and care was given to the facilitation process so that no particular company operating philosophy dominated the process. Individuals representing a wide variety of pipeline operating skills, experience, and technical training programs from companies operating in a number of states volunteered their service to the task force.

The nature of the operator qualification regulations requires that operator qualification plans, covered task identification and qualification evaluation must reflect individual operating company conditions. Therefore, this guide does not imply an endorsement by KGA nor by any of the member and non-member companies whose employees participated in its development.

About "The Guide"

Each subpart of 49 CFR 192 was reviewed by a task force and each section within the subpart classified as applicable or non-applicable to the four-part criteria used to establish a covered task.

The sections considered non-applicable were reviewed and classified using the following criteria: procedures, referenced in other subparts, and/or information. These sections are shaded.

Only KGA Members may have access to the Operator Qualification Covered Tasks Justification Guide.
