- Annual Report Reviews Gas loss



#### Reminders

- Have you updated and reviewed Plans as required.
- Is Operator Qualification tasks current?
- Is you annual fusion up to date
- Have you met and maintained liaison with emergency officials per emergency plan and public awareness plan.

#### Reminders

- Verify 50 % of gas employees being drug tested
- Supervisory Drug / Alcohol Training
- Review Public Awareness Requirements
- Records (If it is not written down it did not happen)

# **Top Findings**

- Not maintaining records
- Manuals not meeting 192 Requirements
- Contractors not properly Operator Qualified
- Employees not proper OQ Qualifications
  - Hands on and Test
- Employees not properly trained
- PAPE
- Not doing what plan says

- Complete 2022 Inspections
- Return to normal inspection protocols
- Complete Section 114 Inspections
- 20 % construction inspections
- 2023 work plan
- Implement 2023 quarterly virtual meetings
